The College Curriculum Committee met November 27, 2018. Chairperson Dr. Bill Tollner called the meeting to order at 12:45 p.m. in Driftmier 102.

The Minutes of the October 16, 2018 meeting were approved.

Updates and Announcements:

- Dr. Tollner shared that the next meeting of the University Curriculum Committee is scheduled for January 18, 2019
- Julie Cook shared that the suspension of any approved course proposals is still in place and that she has requested a timeframe update from Curriculum Systems.

The Committee reviewed the following course proposals (note—following discussion of the ECE proposal, Dr. Tollner reordered the agenda such that the New Business items from Dr. Hornak were discussed prior to review of the ECAM proposals)

- CSEE 4XXX/6XXX—Microcontroller Interfacing--New Course Proposal-- Following discussion including input from Dr. Beyette as the initiating instructor, the proposal was approved.
- ECAM submissions
 - ENGR 8120-Bayesian Methods in Engineering and Environmental Sciences-New Course Proposal—revised submission—Following discussion including input from Dr. Stooksbury as the initiating instructor, the proposal was approved.
 - ENGR/INFO 8110—Informatics in Engineering and Environmental Sciences-New Course Submission-revised proposal-- Following discussion including input from Dr. Stooksbury as the initiating instructor, the proposal was approved.
 - ENVE 8XXX-Advanced Environmental Hydraulics-New Course proposal-- Following discussion including input from Dr. Tollner who was involved in the proposal development, the proposal was approved.
 - MCHE 8980—Aerosol Science and Engineering-New Course proposal— During the discussion phase, Dr. Thompson raised the issue that the course number should be changed as this sequence is used for other purposes. He suggested the number MCHE 8650. The proposal was approved with this amendment.

It was agreed that no action would be taken at this time and the proposals would be first reviewed by the individual School Curriculum Committees for feedback before any vote was taken.
